**Coronavirus (COVID-19) Daily Update
April 9, 2020**

The City and County of San Francisco has issued a Public Health Order requiring that residents stay home, with the only exception being for essential needs, which has been extended through May 3, 2020 in order to slow the spread of coronavirus and preserve critical hospital capacity. The new stay-at-home order supersedes the previous order and went into effect at 11:59 p.m. on Tuesday, March 31. It is a complement to the indefinite statewide stay-at-home order issued by Governor Gavin Newsom earlier this month. [Link to the order here.](#)

The most important thing that people can do is to follow the Public Health Order to stay home except for essential needs, practice social distancing, wash hands frequently and look out for one another.

Laguna Honda Hospital (LHH):

As of April 9, Laguna Honda Hospital currently has 17 confirmed cases of COVID-19, the disease caused by the coronavirus. Thirteen of the confirmed cases are staff and four are residents. Of staff, 10 have been in patient-care positions and three have not. We expect more cases of COVID-19 in the Laguna Honda community, among staff and residents, because the virus is now spreading throughout the Bay Area. Laguna Honda residents and families can receive a pre-recorded daily updates via phone by calling (415) 759-2190. It will be updated each day by noon in English, Spanish and Chinese.

The City requested help with the Laguna Honda outbreak from the California Department of Public Health Department (CDPH) and the CDC, and those agencies have sent experts to work on site including infection control nurses (CDPH), infectious disease physicians (CDC) and epidemiologists (CDC). These experts have insights from around the country and across the world to help us do better in our response.

To ensure the safety of residents and staff, a Public Health Order was issued placing Laguna Honda Hospital under protective quarantine. [Link to the announcement here.](#) [Link to the order here.](#)

Commercial COVID-19 Lab Testing:

Commercial and clinical laboratory COVID-19 testing options are currently available to the public upon clinician referral. All COVID-19 test results must be reported to the State and local health authorities. The City and the SFDPH Public Health Laboratory continue to prioritize limited COVID-19 testing resources for hospitalized patients; vulnerable, at-risk populations; and front line first responders and health care workers providing essential services during the COVID-19 pandemic.

People Experiencing Homelessness

Five guests at the MSC South shelter have tested positive for COVID-19. The patients are not currently at the shelter, and are currently recovering at an isolation hotel. The Department of Homelessness and Supportive Housing is working with the Department of Public Health on a response to ensure the safety of guests at the shelter. Actions include contact investigations, screening of guest and staff, testing of those showing symptoms, improvements to the physical

space including cleaning, and relocation of guests in vulnerable populations to other sites.
